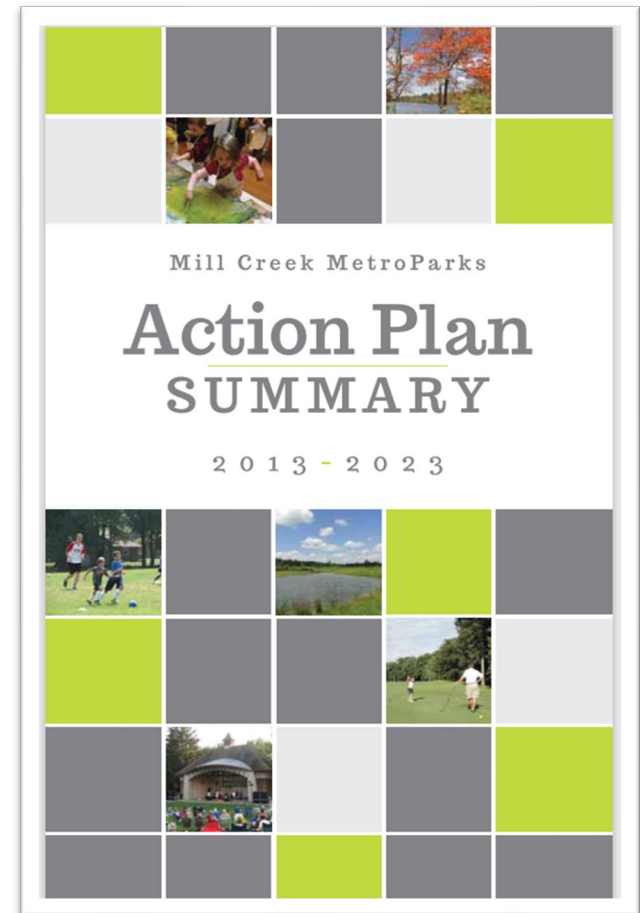

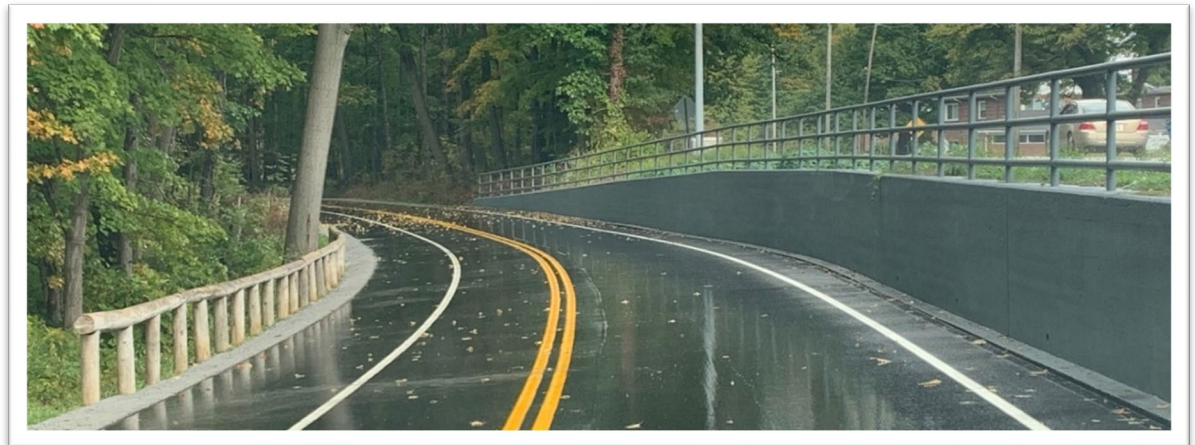

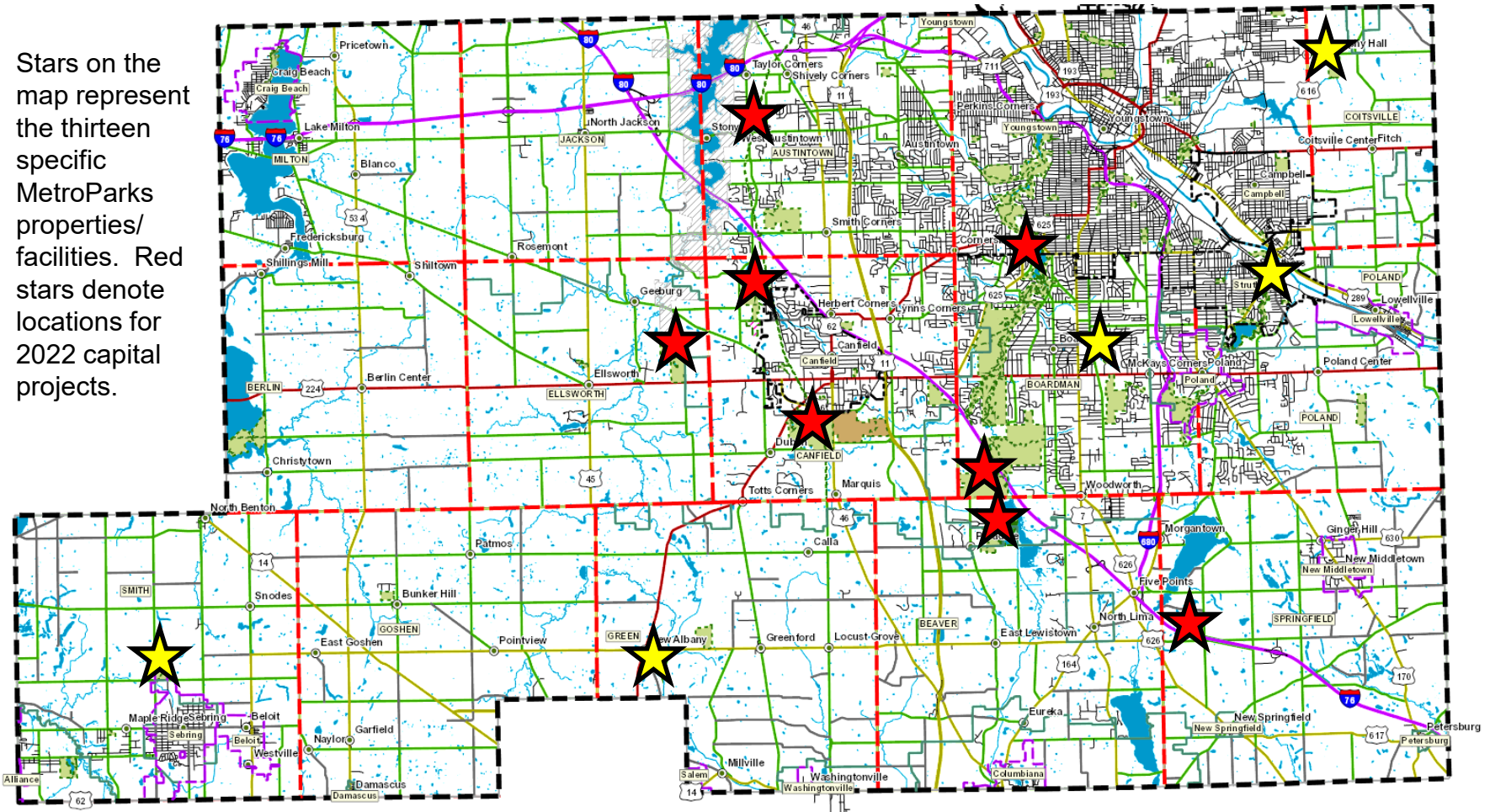
Department Mission

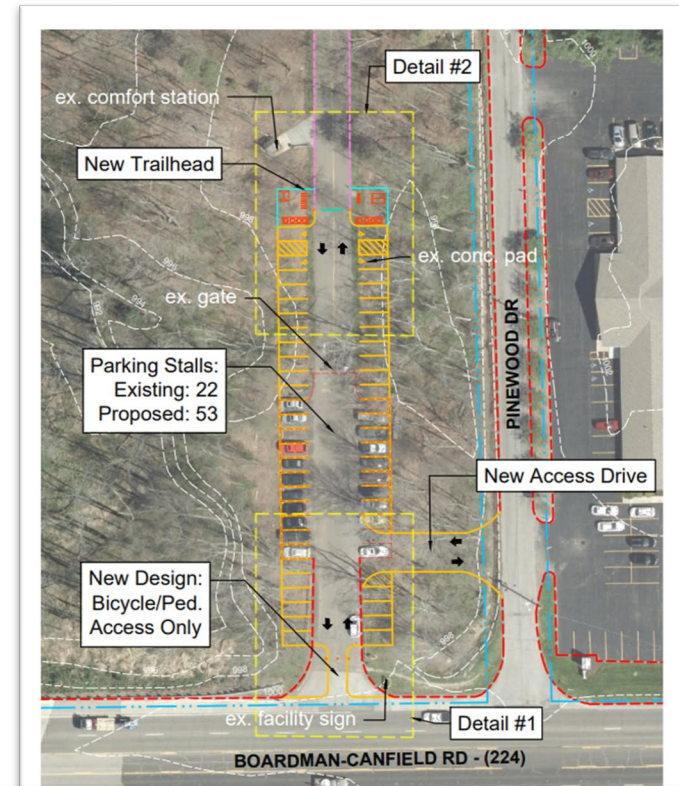

2022 Capital Improvements

Annual Parking Lot Improvements

- \$150,000 Budgeted
- East Golf Hike & Bike Trail: South (224) Lot & Neighborhood Entrances
 - Expand number of parking stalls
 - Improve vehicular and bicyclist/pedestrian circulation
 - Improve trailhead amenities
 - Compliment recent trail and parking lot improvements
 - Improve and standardize trail connections from adjacent neighborhoods to the east
 - Work includes excavation, grading, asphalt paving & pavement markings, signage, bollards and gates
- Annual Preventive Maintenance
 - Crack filling, asphalt sealing & pavement markings



Annual Trail Improvements

- \$129,000 Budgeted
- Mill Creek Park Hiking Trails
 - Funded through the Beeghly Family
 - West Newport Trail
 - Improvement to trail surfacing, stormwater drainage and infrastructure, signage, access
- Vickers Nature Preserve
 - Funded through endowment funding
 - Equestrian trail improvements
 - Partially funded by private donation
- Sawmill Creek Preserve Hiking Trail
 - Construction of bridge, signage, markers
- Collier (MC) Preserve Hiking Trails
 - North parcel and hillside trail improvement
 - Signage
- MetroParks Bikeway
 - Erosion repair and stormwater infrastructure



Annual Signage Improvements

- \$25,000 Budgeted
- Facility Signage
 - Regional facilities
- Mill Creek Park Road Names & Wayfinding Signage



Annual Pavilion Improvements

- \$50,000 Budgeted
- Stitt Pavilion
 - Roof Replacement
- Bears Den Maint. Facility
 - Building/Roof Repairs and Improvements



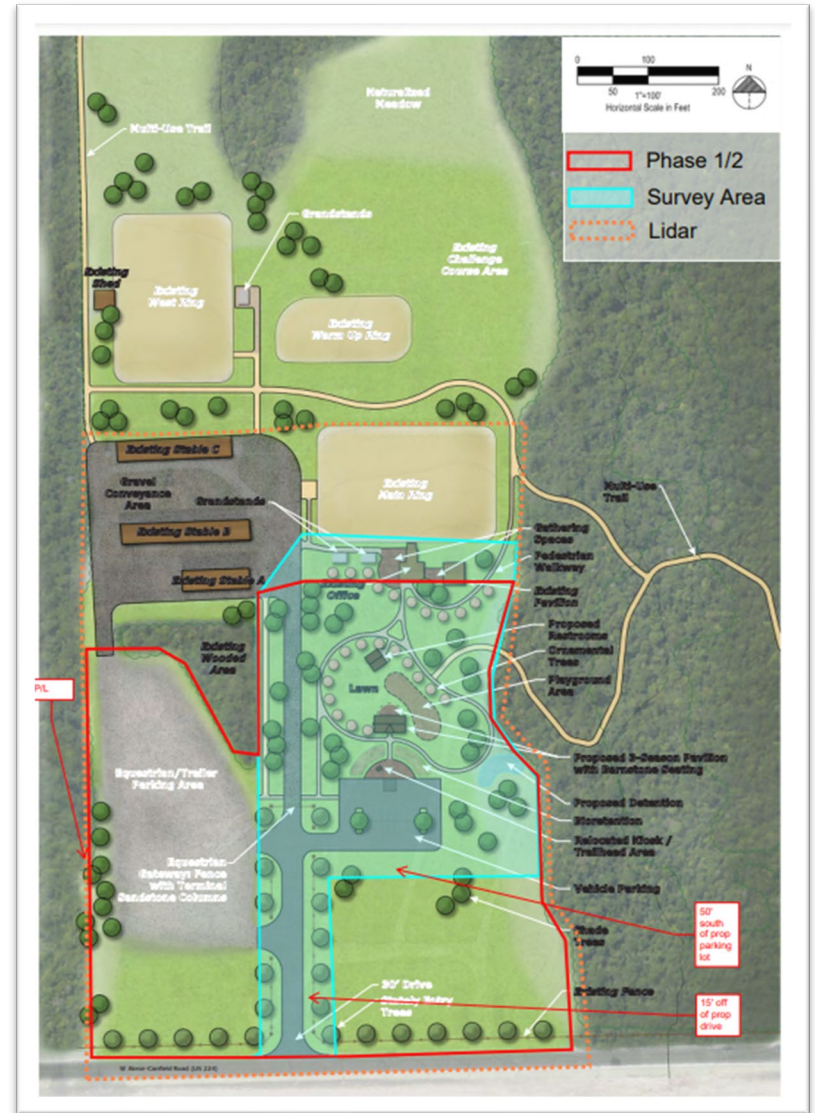
Golf Course – Indoor Training Facility

- \$400,000 Budgeted
 - \$41,000 through Donald Ross Society and Golf Endowment funding
- Fieldhouse 2nd Floor Redevelopment
 - Three (3) Bays with Golf Simulators
 - Putting Green
 - Club Fitting Area
 - Office
 - Restrooms
 - Storage



Vickers Nature Preserve Improvements

- **\$250,000 Budgeted**
 - \$5,500 through endowment funds
- **Phase I Master Plan Improvements**
 - Vehicular, Equestrian and Pedestrian Circulation
 - Public Parking Lot
 - Truck & Horse Trailer Parking Lot
 - Entry Drive
 - Frontage Treatment/Curb Appeal
 - Stable/Horse Drop-off Improvements
 - Stormwater Management Infrastructure
 - Demolition

Lanterman's Mill Site

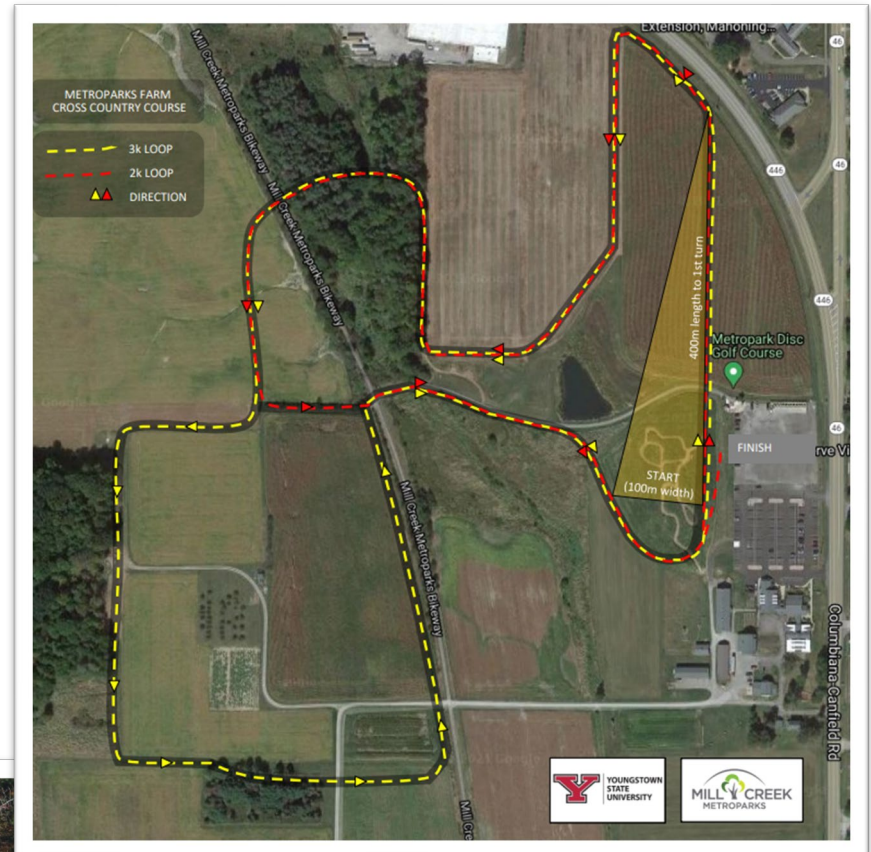
Improvements

- \$100,000 Budgeted
 - \$11,000 through Mill endowment funds
- Covered Bridge Remediation
 - Cleaning and maintenance
 - Repainting of beams and structural component
- Mill Entrance/Deck Improvements
 - Repair to Front Entrance into the Mill



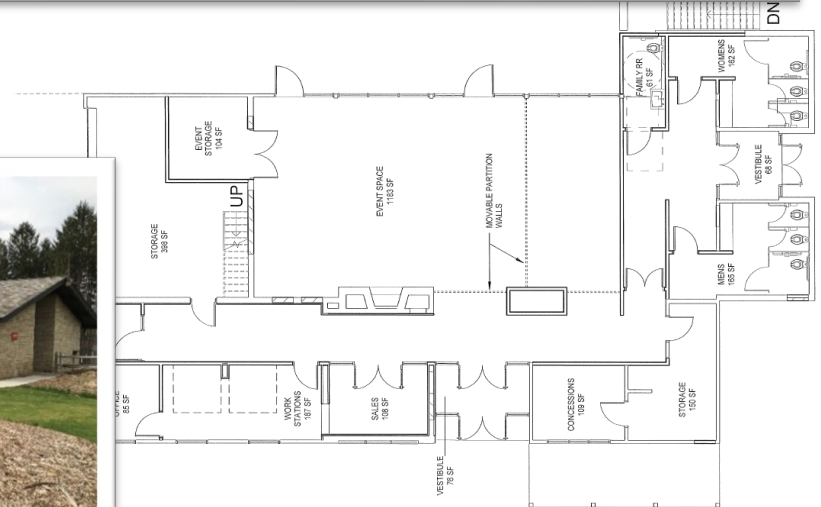
MetroParks Farm Improvements

- \$50,000 Budgeted
- NCAA Cross Country Course Development
 - Integrate a permanent XC course into the Farm Landscape
 - Provide course of community use
 - Special use by middle schools, high schools, YSU Cross Country
 - Work includes excavation, grading, seeding and mulching, additional surfacing, signage, etc. to meet NCAA and national standards



- **\$1,300,000 Budgeted**
 - \$800,000 Carryover and \$500,000 new 2022 funding
- **Redevelopment of Warming House and Adjacent Site Improvements**

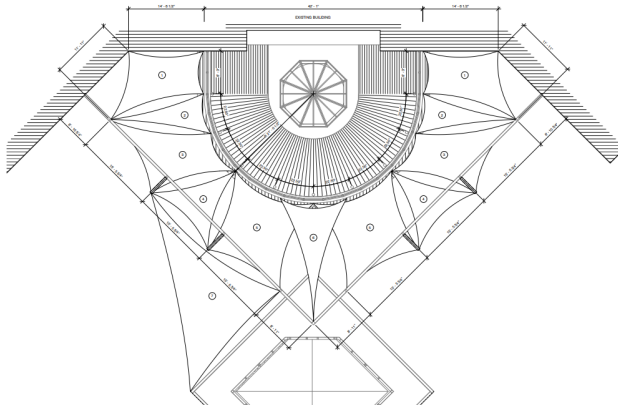
Mill Creek Wildlife Sanctuary & Collier (Mill Creek) Preserve Improvements

- \$50,000 Budgeted
- Prescribed Burn – Upland Prairie
 - A controlled burn throughout ~45 acres
- Habitat and Site Improvements
- Vegetative Invasive Species Control



Fellows Riverside Gardens Improvements

- \$97,000 Budgeted
 - 100% Endowment Funds
- Davis Education & Visitor Center
 - Terrace canopy (shade structures) and seating
- Rose Garden
- FRG Site Improvements



Professional Consultant Services: Contracted Design / Contract Administration

- **Fellows Riverside Gardens Site Improvements**
 - \$50,000 Budgeted
 - Children's Garden - Design Development & Construction Drawing Preparation
- **Wick Recreation Area**
 - \$50,000 Budgeted
 - Wick Recreation Center Redevelopment - Construction Administration
- **Mill Creek Golf Course Improvements**
 - \$40,000 Budgeted
 - Indoor Training Facility - Construction Administration

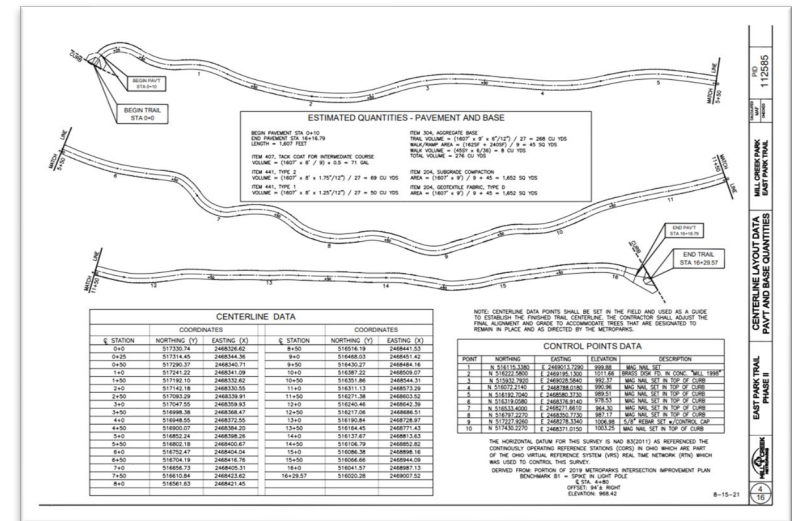
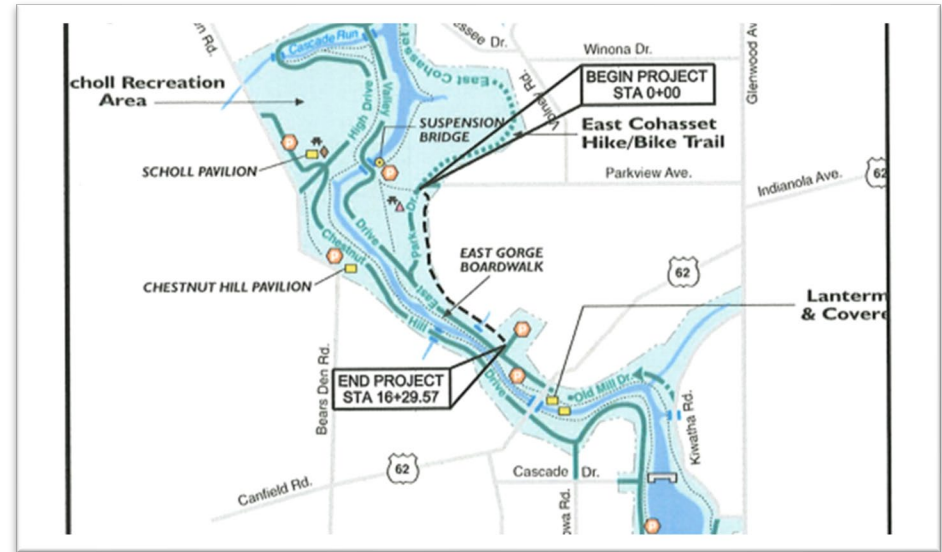
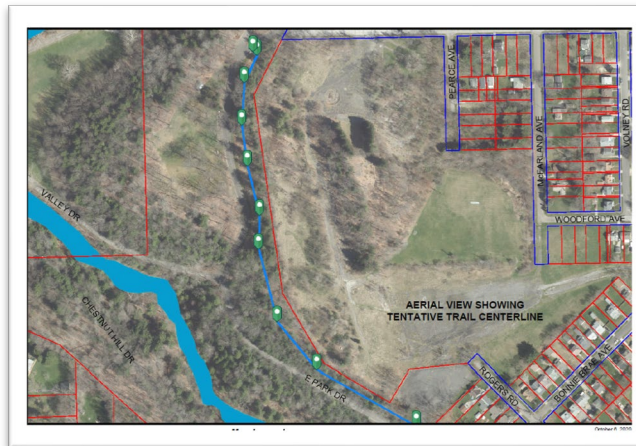

MetroParks Bikeway Phase III Construction

- \$4,279,875.00 Budgeted
 - \$3,423,900 from Third Party Funding (CMAQ, Fed. Appropriation)
- Construction of 6.4 miles
 - Western Reserve Road to Route 14 through Green Township into Washingtonville

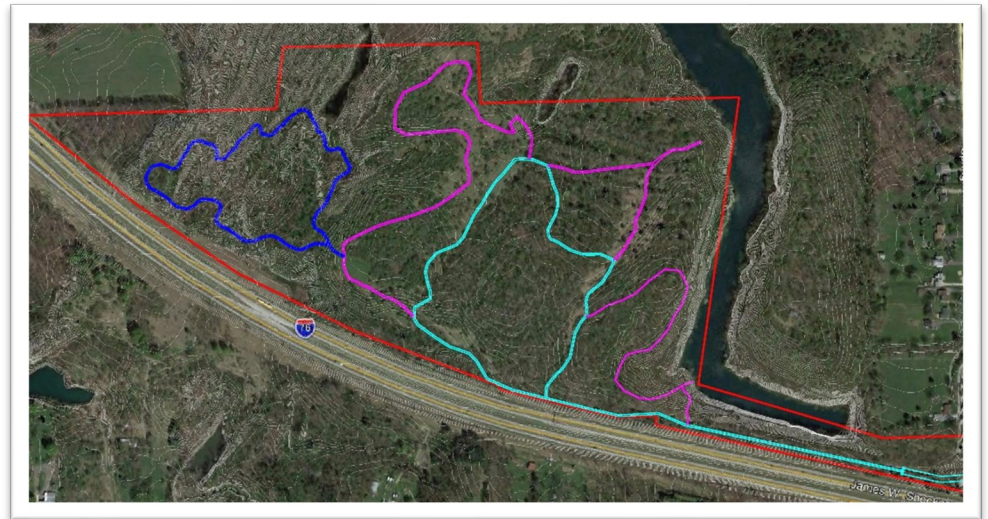


- **\$170,000 Budgeted**
 - \$136,000 grant from Transportation Alternatives Program Funding
- **1800 LF, 8' wide Asphalt Trail**
- **Connects Idora Parking Lot to East Cohasset Hike & Bike Trail**



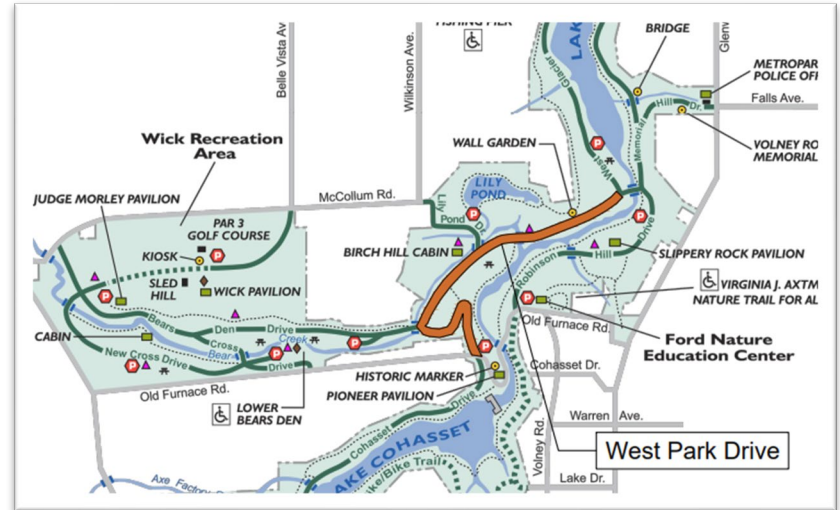
Springfield Forest Improvements

- \$242,963 Budgeted
 - \$182,202 through Ohio Public Works Commission (OPWC) Clean Ohio Conservation Fund Grant
- Improvements to Improve Accessibility
 - Aggregate entry drive
 - Aggregate parking lot
 - Improved trail system
 - Fishing opportunities and pondside access
 - Habitat restoration
 - Signage, kiosk and benches



Annual Drive Improvements

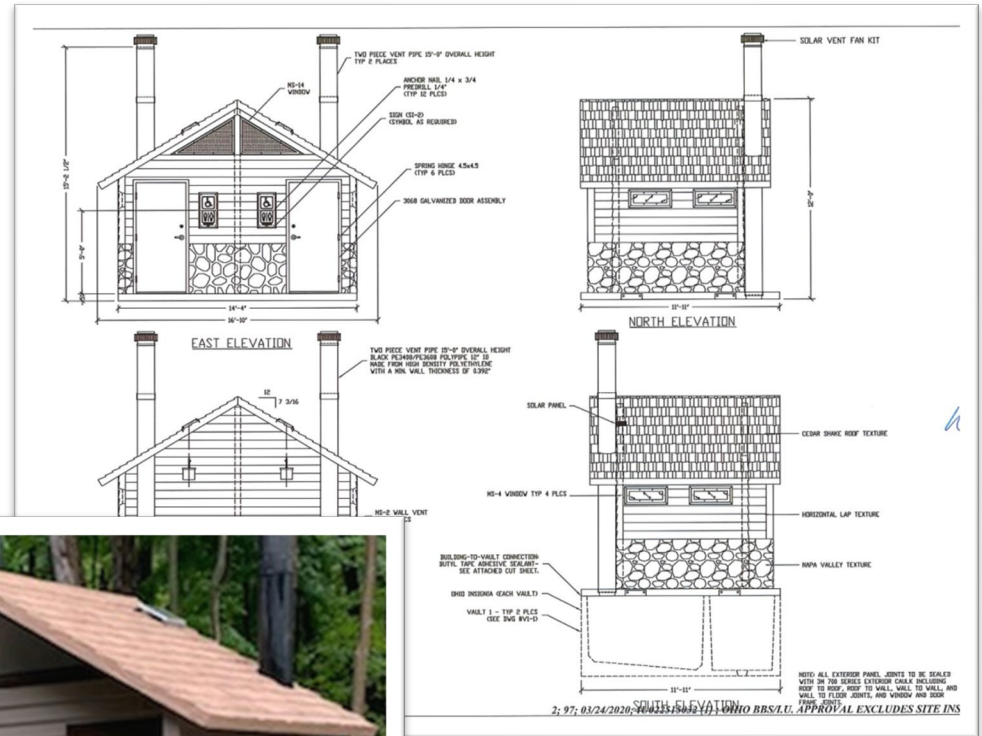
- **\$350,000 Budgeted**
 - \$115,000 from Biennial ODOT/OPRA Park District Road Tax Allocation
- **West Park Drive**
 - Infrastructure Improvements: Storm drainage structure & pipe replacement, ditch excavation/grading, bollard replacement, curbing improvements
 - Resurfacing Improvements: Asphalt paving, pavement markings, aggregate shoulders
- **Drive Maintenance**
 - Reapplication of pavement markings
 - Crack filling
 - Lane Paving (Overlay)
 - Aggregate shoulders
 - Linear Grading
 - Bollard Replacement



2022 Capital Improvements

Annual Comfort Station / Restroom Improvements

- \$80,000 Budgeted
 - \$15,247.00 through Ohio Department of Natural Resources (ODNR) NatureWorks Grant
- Construction of new, precast concrete, vault restroom on golf course
