Resolution Honoring Retiring Recreation Director, Thomas J. Bresko

Whereas, Tom Bresko began his career with Mill Creek Park in 1973 as a seasonal employee

and was promoted to Recreation Director in 1977, and

Whereas, from 1977 to 1981, Tom directed the operations of Pioneer Pavilion, Slippery Rock,

Chestnut Hill and Walter Stitt Pavilions, Volney Rogers, Walter Scholl, and James Wick Recreation Areas, and the Lake Glacier and Lake Newport Boathouses, and

Whereas, beginning in 1982 Tom took on additional administrative duties of Ford Nature Center, Lanterman's Mill, MetroParks Farm, including the development of the Mindy Henning

Nature Trail, Yellow Creek Park, The Graphics Division, Vickers Nature Preserve, and McGuffey Wildlife Preserve, and

Whereas, Tom expanded recreational programming including annual events which he conceived

and coordinated, such as Easter Eggstravaganza, Sunset at the Farm, and Sunfest. Tom has had

enormous influence in the creation of The Nature Photography Exhibit, Boy Scout Earth Day

Clean-up, Halloween at the Morley, Reptile & Raptor Exhibit, Bug Day and Olde Fashioned Christmas at the Mill which annually attract thousands of visitors, and

Whereas, Tom cultivated relationships with community organizations and encouraged them to

use the MetroParks for fun and fundraising events, from road races large and small, including the

Peace Race, bicycle races, walk-a-thons, and other special events that bring participants from  $\$ 

around the world, into the MetroParks who may otherwise never visit, and

Whereas, Tom set a record for longevity breaking the previous record of the Park's first.

Recreation Director, Walter Scholl, It was often said that "no one made more friends for Mill

Creek Park than Walter." Tom, with his quick wit, warm personality and hard work, continued

Walter's legacy making countless friends for Mill Creek MetroParks.

Whereas, Tom became the MetroParks Interim Executive Director, in September 2009, and served in that position until December 2010, when he became the Deputy Director for the MetroParks, and ended his career helping with the transition of the new Executive Director, and Recreation Director.

Now Therefore Be It Resolved That, The Mill Creek MetroParks Board of Park Commissioners

and staff wish to thank  $Tom\ Bresko$  and honor  $him\ for\ his\ outstanding\ service$  to the MetroParks

and this community, serving in each of the past 5 decades, and that upon Tom's retirement, and

due to his dedication and devotion to the Mill Creek MetroParks, it is proposed that the Pavilion

in the James L. Wick, Jr. Recreation Area be named the Thomas J. Bresko Pavilion.
