A SEPARATE

POLITICAL SUBDIVISION

OF THE STATE OF OHIO

Mill Creek MetroParks is a separate political subdivision of the state of Ohio and is not part of any local or other political subdivision. It was established on January 1, 1989, under Chapter 1545 of the Ohio Revised Code, as the successor to the Youngstown Township Park District subsequent to the voters' approval of the conversion. Mill Creek MetroParks serves all of Mahoning County.

The MetroParks currently operates Mill Creek Park, located in Boardman Township and the City of Youngstown, Yellow Creek Park in Struthers, the MetroParks Farm in Canfield Township, Vickers Nature Preserve in Ellsworth Township, MetroParks Bikeway, which traverses Austintown Township, Canfield Township and the City of Canfield, Sebring Woods in the Village of Sebring, Cranberry Run Headwaters in Boardman Township, Sawmill Creek Preserve in Canfield Township, Mill Creek Preserve in Boardman Township, McGuffey Wildlife Preserve in Coitsville Township and Mill Creek Wildlife Sanctuary in Beaver Township.

MetroParks revenue is derived from the three main sources: receipts of a tax levy upon all real estate within the District, receipts from the Local Government Fund and income from MetroParks facilities such as greens fees, rentals of cabins, pavilions, and boats, lesson programs, and other activities.

THINGS TO DO IN THE MetroParks

From the eclectic to the ordinary, there's something for everyone at Mill Creek MetroParks. Fulfill your dreams or find your heart's desire with activities that run the gamut from active to passive. Classes in horticulture, pottery or agriculture may teach you skills you never knew you had. Improve your health with a variety of fitness classes. Attend a special event and make family memories that last a lifetime. Have a picnic. Take a walk. See the leaves turn. Cross country ski. Transcend the seasons in Mill Creek MetroParks.

The annual Halloween at the Morley underwent a metamorphosis this year and was reimagined as the Spooktacular Funfest. The event entertained several hundred children and their families with

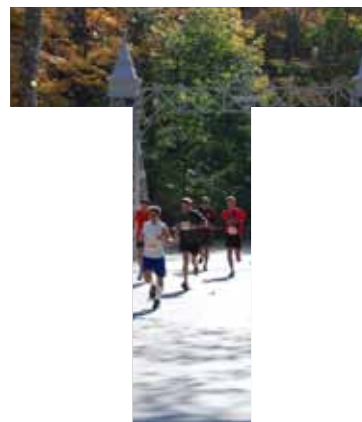
activities such as trick-or-treating at vendor booths, game areas, a petting farm, balloon animals by Jocko the Clown, and of course, the costume competitions. A concert by Hey Kid wrapped up the day's excitement.

Pick-a-Pumpkin Sunday, offered for the first time at the MetroParks Farm, gave visitors the opportunity to pick and purchase Farm-grown pumpkins in the new pumpkin patch. Guests had the opportunity to decorate their prized pick before taking it home. In December, Santa's Winter Barn attracted nearly 500 visitors. Children not only visited with Santa Claus himself, but were able to get acquainted with animals from all corners of the world.

Kayak excursions down the beautiful waterways of Mill Creek Park enjoyed increased participation. New this year were a first ever night paddle on Lake Glacier in June, a trip down the Cuyahoga River from Kent in July, and a midnight float on Lake Newport in August to observe the Perseid Meteor Shower. Our dedicated group of volunteers helped make all of our summer kayak programs possible.

Hiking is one of the most popular activities in the MetroParks. Some new and innovative hikes this year incorporated fishing, whittling, nature journaling, a night walk in Poland Municipal Forest, a salamander search in Sawmill Creek Preserve, and a tour of Berlin Reservoir's dam.

The addition of health & wellness classes gave participants an opportunity to work on their fitness goals with a certified instructor. Pilates, piloxing, and resistance training workshops were added to existing yoga and T'ai Chi classes. Sports camps and clinics provided children with one-on-one instruction from experienced coaches. Classes offered included a tennis camp, batting clinic, and volleyball clinic. Outdoor recreation opportunities such as a family archery class, an air rifle target shooting & safety class, and biking classes were also offered throughout the year. Challenger Sports' British Soccer Camp, a first for the Mahoning Valley, taught young players soccer skills, as well as self-



discipline, good sportsmanship, and respect for others and the game from a team of international experts,.

In October, Masquerade at the Mill—where "mother nature met the Phantom of the Opera"-- was enjoyed by our elegantly-clad guests, many of whom never before experienced Lanterman's Mill. Working with Hands On Volunteer Network, this first-time event was a great success, raising funds for both organizations.

Hooked on Fishing, organized by the MetroParks Police Department, expanded to include two more locations. In addition to Yellow Creek Park, Vickers Nature Preserve and the MetroParks Farm also hosted the program. With this expansion came the opportunity to reach a wider base of young people as well as a prestigious award for those instrumental in the program's success. Assistant Police Chief Bruce Emery, Sergeant Randy Campana and Officer Patrick Murphy were all presented with the Mahoning Valley Chiefs of Police Community Policing award for their efforts.

The traveling exhibit "Wild Land – Thomas Cole and the Birth of American Landscape Painting" was on display at the Weller Gallery early this year. On loan from Mid-American Arts Alliance and funded through the National Endowment for the

Humanities initiative "NEH on the Road", this exhibit significantly increased the visitation to Fellows Riverside Gardens during its run. Concurrent with the exhibition, a three day orientation and training session took place at Fellows Riverside Gardens for organizations wishing to host the exhibit. Nearly 25 groups from across the country attended this session, exposing Mill Creek MetroParks and the City of Youngstown to a brand-new audience.

The annual Pumpkin Walk at Twilight experienced its largest visitation ever, with an attendance of 7,040 recorded during the one-day exhibit at Fellows Riverside Gardens. Other popular events at Fellows Riverside Gardens saw increased attendance as well. Winter Celebration-The Snow Garden and Winter Nights attracted quite a few more visitors than last year. The Shop in the Gardens saw sales increase nearly 41% during the wildly popular Girls Night Out at the Gardens. The annual summer Garden Party fundraiser was also well attended--over 300 guests experienced *Sugar Beets Meet City Streets*.

Due to the untimely arrival of spring, tulips peaked early this year. Visitors to Fellows Riverside Gardens and Mill Creek MetroParks enjoyed the displays during the second week of April instead of the first week of May, the normal peak bloom time.

"Beads for Trees", an outdoor art exhibit at Fellows Riverside Gardens, encouraged the community to pay homage to trees by creating a string of beads to be hung in the foliage at Fellows Riverside Gardens. Beads for Trees was a part of Living As Form, a national art project that was created in 1991.

The Players Club, a new customer loyalty program at Mill Creek Golf Course, was created to reward frequent golfers. The program gives golfers a 10% reward to use in the future towards their greens fees.

The new practice range and learning center at Mill Creek Golf Course was 90% completed by the end of the year. The staff will put the finishing touches on the project in the spring of 2013. The design work for the support structure housing the ball dispenser and teaching studio should be complete in May.

The first ever Mill Creek MetroParks Rib Burn Off was held at the James L. Wick Jr. Recreation Area in May. Six rib vendors, thirteen bands and an assortment of vendors kept the crowd well fed and content during the three-day event. Picture-perfect weather helped MetroParks staff raise \$12,000 for the new Children's Play Area.



A LIFETIME OF LEARNING



After several years of meticulous work, cataloging the literary collections in the Maxcine Antonucci Horticulture Library at Fellows Riverside Gardens were completed. One hundred eighty-five new items were added to the collection this year, bringing the total titles to 3,516.

Over 2500 students from Youngstown and other districts visited Fellows Riverside Gardens for a variety of horticulture education programs. Indoor classes, as well as outdoor Botanical Discoveries programs, gave students insights into the world of plants.

Ford Nature Center celebrated its 40th birthday on July 5 with a party featuring guest speakers Bill Whitehouse and Jay Blackstone. The mansion housing the Nature Center, a gift from the children of Judge John W. Ford, marked its 100th anniversary through a year-long exhibit at the Melnick Museum in the D.D. and Velma Davis Education & Visitor Center.

The Frog Walk held at Vickers Nature Preserve attracted 99 participants. Due to the perfect weather conditions, participants found nearly the same number of frogs during their traipse through the Preserve.

The MetroParks Farm held a two day Ag Camp, "Down on the Farm", in July with 71 campers and 25 volunteer camp leaders in attendance. This year's camp was supported and underwritten in large part by AgLand Co-op and Witmers Feed and Grain. During camp, children participated in fun activities, were taught where their foods came from and prepared some dishes for the family picnic.



Family Garden Fun Days took place in the Family Garden at Fellows Riverside Gardens Tuesdays, Fridays and Sundays throughout the summer. Staffed by horticulture interns and volunteers, this drop-in program was a very successful way to connect visitors to that part of the Gardens.

National Public Gardens Day was celebrated at Fellows Riverside Gardens on May 11th with nationally recognized topiary artist Pearl Fryar in attendance. His visit to the Gardens included a lecture and the creation of a topiary bird house tree in the Family Garden.

The Fall Garden Author Lecture at Fellows Riverside Gardens featured Felder Rushing, Mississippi native and well-known author of 19 garden books. While here, Mr. Rushing aired his NPR radio program. This lecture was co-sponsored with Men's Garden Club of Youngstown and Friends of Fellows Riverside Gardens.

Presentations included Traveling Exhibits for Small Gardens and participation on a panel about Storm Water Management, which focused on the Rainwater Cascade portion of the Ohio Woodland Garden Project.

Horticulture student Nathan Tinsley, a senior in Public Horticulture at Kansas State University, started a summer internship at Fellows Riverside Gardens in mid-May. This position is funded by the Friends of Fellows Riverside Gardens. A second summer garden intern, Meg Knapke, began work in June. She is a Public Garden major at Purdue University.

Lily Martuccio was promoted to the full time position of Graphics and Development Specialist in February.

Horticulture Education Manager Anita Wesler retired on December 14th after 13 years with the MetroParks. Asst. Police Chief Bruce Emery retired after 37 years of service to the MetroParks in December and Officer Wilbert Drayton retired in November with 20 years. Rich Cerimele, Wick Recreation Area Manager, retired with 21 years of service.

VOLUNTEERS

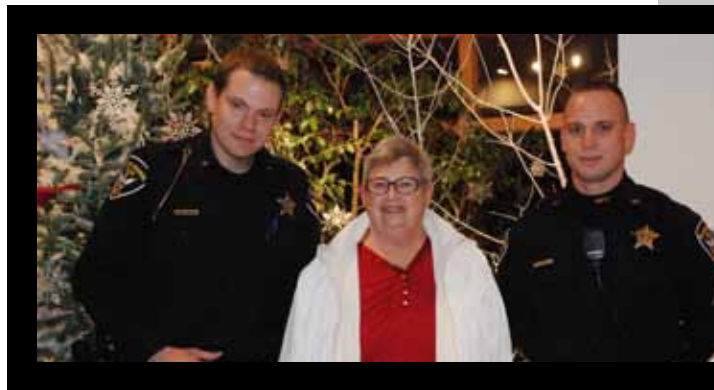
We are fortunate to have the gift of people's time and talents to support the activities that occur at the MetroParks year-round. We celebrated our volunteers' commitment last year at the annual Volunteer Recognition Picnic, held at the Judge Leo P. Morley Performing Arts Pavilion, where our guests enjoyed the upbeat sounds of Redline.

Bridget Beck was hired as the first Volunteer Coordinator at Fellows Riverside Gardens, dedicated specifically to work with garden volunteers. In 2012 the number of volunteer hours recorded reached 14,343, a huge increase from the total number of 7,359 in 2011.

Time recorded for volunteers throughout the MetroParks was 18,859 hours. Based on the state minimum wage (\$7.70), this would have an approximate value of \$145,214.

PARTNERSHIPS & COLLABORATIONS

Fitness Together, a local personal training business, worked with our Recreation Department to hold the first ever race benefitting Mill Creek MetroParks. The event raised \$2,924 for outdoor education in Mill Creek MetroParks.

Many area organizations conduct their races, walks and other events throughout the MetroParks. Road Runners Club Distance Classic Half Marathon, YMCA Memorial 5 Mile Run, Race Against Amyloidosis, American Cancer Society's Bark for Life, Canfield High School's Cardinal Classic Twilight Run, Youngstown YMCA Triathlon, Ohio Naturopathic Couch-to-5k, Mahoning Valley Player's Shakespeare in the Park, Struthers Rotary Club Rubber Duck Race, Covelli Panerathon, YMCA Community Cup, Multiple Sclerosis Walk, Youngstown Ultra Trail Club's 25k & 50k Run, Garden District Neighborhood Association's 5k Race, National Association for Suicide Prevention's Out of the Darkness Walk, Youngstown Peace Race, and Kicks for Kids 5k Race chose to have all or part of their events in the MetroParks. These community events attracted 11,410 visitors.

Mill Creek MetroParks and the Alliance for Watershed Action and Resource Education (AWARE) partnered with the newly formed Friends of the Mahoning River on a display at the Canfield Fair, and assisted with planning of their RiverFest event held in October. AWARE was accepted into the River Network's Building More Impactful Organizations program, which is designed to assist local watershed groups in capacity building. Through the program, AWARE receives consulting services from River Network staff and other resources to help the organization grow and plan for its future in a sustainable fashion.

The MetroParks collaborated with Western Reserve Land Conservancy on a Clean Ohio Conservation Fund grant application to protect wetlands habitat. The grant was approved, resulting in the purchase of 52 acres of property along Middle Fork Little Beaver Creek in Green Township.

A partnership with Eastgate Regional Council of Governments on an assessment of stream habitat quality in the Mill Creek Watershed looked at

physical habitat quality along Mill Creek and several of its tributaries using the Ohio EPA's Qualitative Habitat Evaluation Index.

A stream and wetland restoration project took place at the MetroParks Farm in collaboration with the Mahoning County Engineer's Office. A total of 885 linear feet of channelized stream and 3.7 acres of wetlands were restored and enhanced as mitigation for stream and wetland impacts associated with the County's Western Reserve Road widening project.

Many individuals and groups show their passion and commitment to the MetroParks through their projects. Local Boy Scout of America troop members constructed an information kiosk for the Mill Creek Preserve for their Eagle Scout service project. A YSU graduate student examined soil erosion at Mill Creek MetroParks' Lily Pond and the surrounding watershed and its impact on sediments within the pond for his research project.

MetroParks staff served the community by participating in many local organizations as board members, committee members and volunteers. The diversity of organizations include the Mahoning County Farm Bureau, Peace Race, Ohio Parks and Recreation Association, Rotary Club of Youngstown, Association of Fundraising Professionals, Hands On Volunteer Network, Mahoning Commons Association, and the American Public Gardens Association.

The Mahoning Valley Landscape and Nursery Association partnered with Fellows Riverside Gardens to host the Spring Landscape Clinic. This was a very successful day of educational programs and mini trade show for the local green landscape industry.

Men's Garden Club of Youngstown and Fellows Riverside Gardens-Mill Creek MetroParks hosted the annual Winter Garden Seminar, in which 156 participants attended. The program attracted over a third of the participants from the Mahoning Valley, a third from Western Pennsylvania and a third from other areas of Northeast Ohio. Nearly 30 had never been to Fellows Riverside Gardens before.

A new tool shed was purchased for the Children's Vegetable Garden Program with combined funds from the Mahoning Valley Landscape & Nursery Association, Garden Forum of Greater Youngstown and Mill Creek MetroParks.

Construction of the infrastructure for a new children's play area, consisting of an adventure playground, a tot playground, a sand playground, and sand volleyball courts, began in the spring. The project included demolition of existing features, replacement of all underground utilities, construction of the three lighted, sand volleyball courts, concrete walks, a new terrace for the Wick Pavilion and construction of the infrastructure for the new playgrounds. This portion of the project was substantially funded through a \$400,000 bequest.

At the end of the year, Mill Creek MetroParks accepted a generous and thoughtful gift from long-time supporters Bruce and Nancy Beeghly. The Beeghlys donated 6 acres of property, including a 3600 square foot residential structure, to the MetroParks. The property lies adjacent to Yellow Creek Park in Struthers and Poland Township and contains a hiking trail and other features.

Fred Martin Ford donated a Dodge Grand Caravan for use in the MetroParks. This vehicle will be assigned to Fellows Riverside Gardens and used for picking up plants and supplies, as well as, for staff attending meetings.

MAINTAINING THE MetroParks

Much goes on behind the scenes to keep Mill Creek MetroParks looking great. Just some of the day-to-day activities include rental facility cleaning & maintenance, comfort station cleaning & maintenance, trash, litter & recycling collection and processing, vehicle and small equipment maintenance and repairs, and pothole repair & patching on park drives.

Each season brings its own challenges to our hardy maintenance staff. Snow & ice were removed from drives, parking areas, walkways & facilities, and setup and tear-down of pavilions occurred in the spring and fall. The snow making machine and associated water line at the Wick Recreation Area, along with Sled Hill, also were put up and torn down for the season. Grass mowing & trimming of lawns, meadows, facilities & frontages is a never-ending task during the summer months. Cleaning, delivery and pick-up of pedal & row boats from Lake Glacier & Lake Newport as well as setup and tear-down of ball fields keep our crews busy. Maintenance and repairs on our miles of hiking trails is an ongoing task.

In addition to the continuing tasks performed by our Maintenance Department, more extensive projects inevitably crop up each and every year. The Orchard Meadow Comfort Station received interior and exterior renovations, and the women's restroom at the Ford Nature Center was also updated. A new gift shop was constructed at the MetroParks Farm in McMahon Hall, while the hall itself received a stunning new paint job and new laminate floors. At historic Lanterman's Mill, exterior siding, doors and fencing of the restroom building were refinished. The picnic shelter at Volney Rogers Field was refinished, and four deteriorated steel man-doors at MetroParks Service Facility were replaced.

Sadly, our Forestry Crew had to remove over 375 ash trees infested with Emerald Ash Borer, most of them along East Golf Drive. The battle against Emerald Ash Borer in the MetroParks continues with the removal of trees infested with this invasive insect by the Forestry crew. Unfortunately, most of the Ash trees in the MetroParks will ultimately become infested with this invasive Asian species and will need to be removed. However, a few trees that grow in prominent landscape sites have been treated with an insecticide to preserve them.

The landscape surrounding the Volney Rogers Statue at the Glenwood and Falls Avenue entrance to Mill Creek Park was redesigned. New plantings included 60 boxwood shrubs that formed a hedge, and 60 red double Knockout roses that filled in behind it. This design reflects the original plantings from the 1920's, when the statue was first installed.

The Landscape crew combined efforts with our Planning Department to install a wildlife garden at the corner of Lakeview Road and Mayfield Avenue in the Garden District neighborhood of Youngstown. A certified butterfly garden was included as part of the project.

At Lanterman's Mill, a newly designed 'Flight of Fancy' butterfly Garden was installed. This brings the total butterfly gardens in the MetroParks to eight.

The majority of bulb planting took place in October, with over 50,000 planted at Fellows Riverside Gardens. Bulbs were planted by the Landscape staff for spring display in other areas of the MetroParks also, including additional Narcissus at Daffodil Meadow. At Mill Creek Golf Course, three new permanent beds and one new annual planting area were added to the landscape.



NATURAL AREAS & CONSERVATION

This year marked the second in a row for active Canada goose management in Mill Creek Park. The large population of Canada geese not only affects water quality but their aggressive behavior can be dangerous for MetroParks visitors. Staff worked closely with the Ohio Division of Natural Resources to help reduce the number of goose nests within Mill Creek Park.

In October, staff and volunteers flocked to the Mill Creek Wildlife Sanctuary to participate in the “Big Sit”, an annual international bird observation and

recording event. A total of 77 bird species were observed from sun-up to sun-down, beating the previous year’s results and coming in FIRST place for sites competing within Ohio.

New “Wildlife Habitat Area” signs were developed to inform park visitors that reduced mowing frequency in the area is beneficial to local wildlife.

Several Youngstown State University graduate students worked with the MetroParks on research projects throughout our natural areas studying

songbirds, invasive plant species, and other topics. Their studies benefit the MetroParks by providing data that can be used in making important land management decisions.

Through local Boy Scouts, school groups, and concerned citizens, the MetroParks has been able to add a number of wildlife nest boxes throughout our natural areas. These nest boxes not only provide places for songbirds and waterfowl to raise their young, but also provide needed shelter to other wildlife as well.

Grants & Awards

Many major improvements and projects were completed because MetroParks staff diligently looked for alternative sources of funding. These endeavors cannot be funded through the MetroParks budget.
