# Review – February 2017 Presentation

  - Evaluate public program offerings against public needs, and fit to mission. Adjust public programming accordingly.
  - Evaluate school program offerings against Ohio Learning Standards, the needs of community educators and students, and MCMP mission. Adjust school program offerings accordingly.
  - Implement a comprehensive, park-wide, coordinated approach to interpretive (education) programming.



#### **Review – Board Motion**

### November 13, 2017

"Jeff Harvey, and Kat Paull spoke regarding the Nature Education Standing Committee's recommendation, from the October 10, 2017 Board Meeting, that all school programs offered by Mill Creek MetroParks can be <u>correlated with state</u> <u>standards</u>. Lee Frey motioned that the recommendation be accepted. Germaine Bennett seconded the motion. After discussion, and the roll being called upon its adoption, the vote resulted as follows:

# **Review – Terminology**

### Public Program:

Programs planned on a wide variety of topics for general or specific audiences,

Available to all visitors who have an interest in attending.

These programs are placed on our public calendar of events.



Programs specifically planned for and offered to educators and their students. School programs are not available to the general public.

They are not placed on our calendar of events. School groups are diverse, including formal, non-formal, public, charter, private, homeschool, pre-K through adults, and special needs.





# **Review – Terminology**

#### Correlation with State Standards:

Process of identifying existing connections or relationships between each program element and the statements of required knowledge or skills in the Ohio Learning Standards.

# Alignment with State Standards

Process of making adjustments to programs so that program elements or activities correlate in the best way possible - changing, moving, eliminating, developing activities or even whole programs.



# **Review – Terminology**

## Ohio's Learning Standards

"Learning standards explain the knowledge and skills Ohio students in pre-kindergarten through grade 12 need to have." "Ohio's Learning Standards emphasize skills like critical thinking and problem solving — qualities most sought by today's employers. By teaching our students to apply these skills to what they are learning in school, we can make sure they are on track to graduate from high school and enjoy success in college, careers and life."

# **School Programs – Evaluation**

#### Correlation

- Comparison of school programs with Ohio's Learning Standards
  - Science content statements (2010)
    - Ohio approved revisions to the Learning Standards in February 2018
- Identification of programs currently meeting requested needs
- Identification of programs with promising alignment

#### Example of program element and OLS statement:

Seeds carry the beginnings of plants inside them. A seed has a seed coat covering it for protection. Inside, there is a baby plant. This baby plant is a living thing even while it is inside the seed. Seeds come in different shapes and sizes, and come from different locations according to the plant from which they came.

"K.LS.2: Living things have physical traits and behaviors, which influence their survival."



Kindergarten - Grade 1

A hands-on program that is especially geared for younger students. Learn how pioneer children lived and try your hand at grinding grain. Maximum number of students: 30

Length: 1 hour

Season: Autumn, Spring Location: Lanterman's Mill

Max: 30 students







Grades 1 – 2

Take an exciting journey through a variety of habitats. Learn what makes up a habitat and how these places meet the needs of the creatures within them. Make observations in local habitats to discover and investigate how animals and people interact with them.

Length: 1.5 hours Season: Any





#### **Super Seeds**

Kindergarten - Grade 1

Students will explore the importance of seeds and learn how we use seeds every day. See and touch different colors, textures, and sizes of seeds and learn how seeds travel to new places to grow.

Length: 2 hours

Season: Autumn, Spring







#### Food Power Tower

Grade 2

Explore nutrition based on the current "MyPlate" guidelines. Students will discover the food groups and their sources on the farm. To reinforce food group concepts, students will play a food bingo game.

Length: 1 hour Season: Any





#### Nature Friends

Grade 1

Meet real live nature friends with this handson adventure. Uncover the clues animals leave behind that tell us where they live and what they have been doing. Investigate how the surrounding environment helps fulfill wildlife's basic needs.

Length: 1.5 hours Season: Any

- Upper Elementary Programs
- Focus on Land Forms & Ecosystems
- Collaboration with Youngstown City School District
  - Establishing a basis for working with other school districts within Mahoning County and beyond

# Participation in School Programs

- o 2013: 22,691 individuals
- o 2014: 23,488 individuals
- 2015: 19,236 individuals
- 2016: 21,745 individuals
- o 2017: 23,104 individuals
- 2018 (Jan-June): 10,187 individuals
- 2018 Requests for Autumn: 33 requests,
   representing approximately 1500 students
